**These are the Rules and Regulations for LDEC please read carefully**

- **I agree to CLOSE THE FRONT GATE AT ALL TIMES and LOCK ALL GATES AND DOORS if you are the last to leave the grounds, if failing to do this on a regular basis, your KEY will be taken off of you by the LDEC committee**
- Horse sports are a dangerous activity and horses can act in a sudden and unpredictable manor especially when frightened or injured
- There is a significant risk that serious **INJURY** or **DEATH** may result from horse sport activities.
- I understand and acknowledge the dangers associated with the consumption of alcohol or any mind altering drugs and agree not to drink alcohol or take drugs prohibited by law before or during any horse sports activities at the Leongatha Equestrian Park.
- I agree to wear an approved helmet and appropriate boots with a heal at all times whilst mounted on any horse or pony
- I agree that any dog in my charge must remain on a leash at all times
- I agree to remove all manure deposited by my horse on the grounds including arena's, around float and horse yards/wash and place in poo pit provided before I leave
- I agree to abide by all the house rules of the grounds
- I agree that it is my personal responsibility to take out personal accident insurance (HRCav, PCav or EA) and that I do not hold the **LDEC** or **LEP** accountable for any injury, loss of use, damage or loss of income that may occur from any incident that occurs whilst I am using the Park facilities.
- **Any person not holding an LDEC MEMBERSHIP OR AFFILIATED CLUB MEMBERSHIP is not allowed to ride on the grounds UNDER ANY CIRCUMSTANCES, unless invited to join in on a Rally Day by one of the affiliated clubs or is approved by committee.**
- Private instructors are not allowed to give lessons to members at the grounds unless they hold current EA coaching insurance or an equine private insurance. Regular lessons that intend to be held at the park must be approved by the committee. **LDEC** holds no responsibility or liability for any incident that may occur whilst under instruction. It is the individual's responsibility to make sure that there coach is suitable qualified and insured.
- I agree to follow the directions of the guidelines and rules set out by LDEC and the Leongatha Equestrian Park and that any misconduct or refusal by me to follow any direction of any organiser or official at the Leongatha Equestrian Park can result in the **CANCELLATION** of my participation in the activities or immediate removal from my horse or my membership be revoked.
